Note: To correct an entry after a response, press the star (*) key.

1.	System:	“Welcome to JPMorgan Chase Tax Payment Services. If you are calling from a touch-tone phone, press 1 now.”
	Caller:	Enter 1
2.	System:	“Please enter the pound (#) sign after each entry to speed your call.”
	Caller:	-----
3.	System:	“To report Federal Taxes press 1, for State Taxes press 2.”
	Caller:	Enter 1, then #
4.	System:	“Please enter your Access Code. Your Access code must have a leading zero.”
	Caller:	Enter 01722821, then #
5.	System:	“Enter your 4-digit Password.”
	Caller:	Enter 2487, then #
6.	System:	“This payment is for Tax ID number _____. To continue press 1, to disconnect press 2.”
	Caller:	Enter 1, then #
7.	System:	“Enter the tax type, followed by the pound (#) sign.”
	Caller:	Enter 941, then #
8.	System:	“For a Federal Tax Deposit press 1, for a payment due with a tax return or an IRS notice, press 2, for payment on an assessed tax deficiency press 3.”
	Caller:	Enter 1, then #

Subscript based on tax types (step 9):

9.	System:	For tax types: 941, 720, CT2 (282) “Enter the 4-digit tax-filing period, year followed by the quarter ending month. Valid Quarter ending months are 03,06, 09 and 12.”
	Caller:	Enter 0606, then # (Example: for 3rd Quarter in 2006 please enter 0609)For tax 0, CT2 (282)
9.	System:	For tax types: 706, 926, 940, 943, 945, 1042, 2438, 3520, 6069, 8725, CT1 (281) “Enter the last 2 digits of the tax-filing year for this payment; followed by 12.”
	Caller:	Enter 0612, then # (Example: for 2006 please enter 0612)
9.	System:	For all other tax types: “Enter the 4-digit tax filing period, starting with year followed by month.”
	Caller:	Enter 0604, then #

Calling Instructions (continued)

10.	System:	“Enter the amount followed by the pound (#) sign.”
	Caller:	Enter 2025 , then # (Example: \$20.25 is entered as 2025)
11.	System:	“Enter your 2 digit Verification Code.” (Optional Field, press (#) to bypass)
	Caller:	Enter #, then # (see User Guide)
12.	System:	Enter Tax Due Date.”
	Caller:	Enter 062506 , then # (Example: 25 June 2006 is entered day in MMDDYY format)
13.	System:	“You entered 06/25/06. To confirm an entry, press the pound (#) key. To correct an entry after a response, press the star (*) key.”
	Caller:	Enter #
14.	System:	“This payment is for Tax ID _____, for a Tax Type of ____ for the filing period _____, for an amount of ____ dollars. To accept this information press 1, to start over press 2.”
	Caller:	Enter 1 , then #
15.	System	“Your Tax Payment has been accepted. Your acknowledgment number is: _____. Please record this number for future reference. Repeating: _____.”
	Caller:	-----
16.	System:	“If complete with Federal Taxes, press 1 now. To report additional Federal Taxes press 2 now.”
	Caller:	Enter 1 , then #
17.	System:	“To disconnect press 1 now, to report additional State or Federal Taxes press 2 now.”
	Caller:	Enter 1 , then #
18.	System:	“Thank you for calling JPMorgan Chase Tax Payment Services.”
