- 5. **UV Ink**: Bank's logo is printed on the upper left hand corner with ultraviolet ink, which is visible only under UV light, adding an extra layer of security.
- 6. **Printing of account number**: All cheques have account number pre-printed to avoid any risk of fraud or tampering.
